

REVISED NOTICE

Provisional Part Panel- 9 for Level-5, Part Panel-7 for Level-3 and Part Panel-8 for Level-2 posts under CEN-01/2019

1. Candidates bearing the following roll numbers arranged in ascending order (not in order of merit) horizontally have been provisionally shortlisted for Provisional Part Panel-9 of Pay Level-5 posts, Provisional Part Panel-7 of Pay Level-3 & Provisional Part Panel-8 of Pay Level-2 posts as per their Merit, Community and Post preference under CEN No. 01-2019.
2. The result of candidates whose allotted posts may change and candidates having some shortcoming in their submitted Documents/Biometric Verification or their Medical Fitness report is being withheld.
3. In case of two or more candidates securing same marks, their merit position has been determined by age criteria. Older person has been placed at higher merit and in case age being same, then alphabetical order (A to Z) of the name has been taken into account to break the tie.
4. This is Provisional Part Panel. For remaining vacancy, list of candidates for Re-Document Verification cum Medical Examination will be published later on.
5. Candidature of all the candidates appearing in this provisional Part Panel is purely provisional and is liable to be cancelled in case of any inconsistency/deficiency of the data furnished by them in the online application or any mal-practice on the part of candidate coming to the notice of RRB at any stage of appointment/recruitment process. It may be noted that merely getting placed in the provisional Part Panel does not entitle her/him in any way to an appointment in the railway.
6. While every care has been taken in preparing this provisional Part panel, RRB reserves the rights to rectify any inadvertent error or typographical/printing mistakes.

The name of candidates of this Provisional Part panel are being forwarded to Principal Chief Personnel Officer, North Central Railway, Subedarganj, Prayagraj and Principal Chief Personal Officer, Northern Railway, Baroda house, New Delhi. Further course of action on their appointment will be taken by Principal Chief Personnel Officer, N. C. Railway & Northern Railway after due verification & ensuring fulfilment of eligibility criteria like production of Original/Current Certificates of Educational/Technical Qualification, Date of Birth, Caste, Past Character/antecedents/Affidavits where necessary etc according to the Centralised Employment Notice No. 01/2019 and corrigendum issued thereto from time to time and for which the candidates will be informed individually by the N. C. Railway & Northern Railway. All candidates will be required to submit an affidavit that their Degree/Diploma certificate and Caste certificate, as the case may be, are genuine and valid.
