**SECOND AND FINAL CHANCE OF DOCUMENT VERIFICATION AND MEDICAL EXAMINATION FOR ABSENTEE CANDIDATES ON 23-09-2019**

**Under CEN 02/2019 (Paramedical Categories)**

1. The list of 283 candidates provisionally shortlisted for Documents Verification (DV) was published on the website of Railway Recruitment Board, Allahabad on 11.09.2019. The DV and Medical Examination (ME) of the candidates for the post of Paramedical Categories of CEN-02/2019 was held from 19.09.2019 to 21.09.2019 (03 days) at Shambhunath Institute of Engineering & Technology (SIET), Education Block, Jhalwa, Prayag Raj (Allahabad).
2. For those candidates who were absent for the above DV, it has now been decided to give a second and final opportunity for DV to the candidates remaining absent on scheduled date due to valid reasons beyond the control of the candidates e.g. University/Govt. Examination, Personal Sickness etc.
3. No separate E-Call Letter will be issued to the candidates who are given second chance to appear for DV and candidates are advised to bring the original E-Call Letter issued for the earlier DV alongwith all the original documents mentioned in the E-Call Letter according to CEN-02/2019 and 02 sets of photocopy of the documents. An SMS and E-mail only will be sent to the absentee candidates on their registered Mobile number and E-mail address.
4. Candidates are advised to bring **six (6) passport size** colour photographs NOT MORE THAN ONE MONTH OLD, which will be required for DV and Medical Examination. Candidates will also bring Candidate's foil of e-call letter for CBT. Mobile phones are not permitted during document verification (DV) as well as during Medical examination.
5. It is again made clear that candidature of the candidates not having an appropriate proof of valid reasons for not attending DV on their scheduled date will be rejected and no further opportunity will be given.
6. The candidates need to attend Medical Examination (ME) on the next day of DV duly paying Rs.24/- towards ME fee. The time and place of ME will be intimated at the time of DV. Please note that you should be prepared to stay for 3-4 days for DV/ME at your own cost.
7. Candidates are advised that they should not bring their belongings to the Railway Hospitals as there is no facility available to keep them. They will carry only Admit card for Medical Test (Examination) and one original valid & current Photo ID proof. For medical examination, no fees will be charged at the Hospital. Hence candidates are also advised not to carry cash with them at the time of Medical Examination.
8. The Venue of Document Verification (DV) is **Shambhunath Institute of Engineering & Technology (SIET), Education Block, Jhalwa, Prayag Raj (Allahabad)**.
