- Total 245 (Two Hundred and Twenty Five Only) candidates have been called for typing test for the subject posts.
- Eight times candidates to the number of vacancies have been called for Typewriting Test/ Computer typing test.
- Type Test (25 wpm in Hindi or 30 wpm in English) being mandatory & qualifying in nature for selection of the subject post, all candidates are required to appear in the Typewriting Test/ Computer typing test.
- For appearing in Typewriting Test, candidates must bring their own Typewriting Machine either of English or of Hindi as per their choice of language for typing.
- For appearing in Computer typing test, Computer will be provided by this RRB.

Note:- Instructions to candidates appearing in the typing skill test is attached with call letters as **Annexure-A & Annexure-B**.

The candidates are being advised through Post, but even in case of non-receipt of intimation by post, candidates are hereby directed to report on the specified date and time with all certificates and mark sheets in respect of qualification, age, caste etc. in original along with attested copies & 2 recent photographs for verification. While every care has been taken in preparing the above result, the possibility of inadvertent errors can not be ruled out. The Board reserves the right to rectify the same later on.
