Candidates must bring the following certificates in original (Plus one self attested copy) in support of the following:

1. Date of Birth
2. Qualification
3. Caste Certificate
4. NOC Certificate
5. Photo (2 Copies)
6. Discharge Certificate (Ex-SM)

The OBC Certificates must have the non-belonging in creamy layer clause as per the specified proforma issued by competent authority with in one year. Candidates must ensure that their name, name of their father and other particulars in their original certificates must match with entries made in their application form. SC/ST/OBC candidates must also ensure that the address mentioned in their caste certificates must tally with the entries of permanent address made by them in their application forms.

IMPORTANT: Beware of the touts who may misguide the candidates with false promises of getting them selected for the job on illegal consideration. The recruitment process in the RRB exams is fully computerized and the selection is based purely on the merit of candidates.
